

Gray Reed & McGraw Wins Jury Verdict that Exonerates Landlord

Harris County Jury Rejects Claims Against Medical Properties Trust, Inc., Other Entities

HOUSTON, TEXAS – Gray Reed & McGraw is pleased to announce that a State District Court jury in Harris County, Texas has rejected all claims brought against its client, Medical Properties Trust, Inc. (NYSE: MPW), by a group of physicians whose efforts to create and operate a new hospital in Houston failed in 2006. Jurors in the court of state District Judge Al Bennett found against six doctors who filed a lawsuit accusing Medical Properties Trust, Inc. and others of contributing to the demise of doctor–owned Houston Town & Country Hospital.

D. Scott Funk and James M. McGraw, trial partners with Gray Reed& McGraw, led the defense team for MPT. After a trial that spanned 10 weeks, the jury found unanimously in favor of Medical Properties Trust, Inc. on all counts brought against it regarding the termination of the leases of Houston Town and Country Hospital in 2006. In the lawsuit, the physicians asserted that MPT's actions interfered with their efforts to enroll Medicare patients in a forprofit insurance arrangement that would have resulted in multi-million dollar payments to the physicians from the insurance company.

"We are very pleased that after more than two months in trial, a jury of conscientious citizens quickly reached a unanimous decision in favor of our Medical Properties Trust," Funk said after reflecting on the jury verdict. "We said at the time this suit was filed that there was no merit to these allegations and that we would fight them to the end, and the jury's decision completely vindicated our client."
