

Texas Appellate Justice Jim Moseley Joins Gray Reed & McGraw

He also served four years as Regional Director of the Federal Trade Commission during the Reagan Administration. There he was responsible for enforcing federal antitrust and consumer laws in a five-state area. Moseley is a former Chair of the State Bar of Texas Antitrust & Business Litigation Section, and is an elected member of the American Law Institute.

"Jim's unique experience, including his almost two decades on the Court of Appeals, has given him a broad understanding of what the law is, how it is changing, and the forces driving that change" said Gray Reed President and Managing Partner J.
